

Early Intervention's Literacy Program



In 2022, an extraordinary new program, five years in the making, came to fruition. The Early Intervention Literacy Program, designed and implemented by People Incorporated employee Gloria Bajor, has provided quality books and toys to over one hundred families in our catchment area, many of whom otherwise would not have the resources to buy these materials on their own. The program has worked with mothers who were themselves unable to read and helped them enjoy books with their children.

Feedback from parents who have completed the program has been tremendously encouraging. There have been reports of positive development from many of the children who have finished our ten-week program. Children previously uninterested in books are now sitting and looking at books on their own. Through the program, we have been able to show parents how to expand on books and all kinds of different ways to play with toys. Many parents account that their child has been talking more by the end of the program.

The literacy program is a worthwhile and important part of what we can offer to our families, and it illustrates the strides we have made to establish People Incorporated's Early Intervention program as an enriching fixture in the community.






